## 2015 International Year of Evaluation

UNEG and **EvalPartners** have joined forces in declaring **2015 the International Year of Evaluation**. The global movement for 2015 International Year of Evaluation is making important progress:

- At the global level, consultative processes with Members States to develop a UN resolution on 2015 International Year of Evaluation is proceeding very well. The UNEG Executive Group has already met with Members States from Asia and the Pacific, Africa, Latin America and Western Europe and Others Group (WEOG), and a core group is being constituted to table a UN resolution. A second high-level event –after the one in 2013 with the SG- was held on 26 February 2014.
- At the regional and national levels, 15 countries/VOPEs have already declared 2015 as Year of Evaluation. The African Evaluation Association recently declared this at their bi-annual African Conference.

EvalPartners took the initiative to include the logo of "2015 International Year of Evaluation" in its email signatures. **We encourage you to include the logo of the "2015 International year of Evaluation" in your email signatures** as well. If a critical mass support this action, it will be a cost-effective manner to raise awareness.

## **UNEG Handbook for the Evaluation of Normative Work in the UN System is available now**

The majority of organizations within the UN system are involved in normative work. For many, normative work is at the core of their mandate. The purpose of this handbook is to guide UN Agencies in conducting evaluations of their normative work. It is intended primarily for evaluation professionals in the UN system who are responsible for the management and / or conduct of evaluations of normative work.

The name change emphasizes the structural independence of the Evaluation Office and further clarifies its status to stakeholders. It also promotes credibility of the evaluations conducted by the IEO and underscores the critical role of the IEO as a provider of impartial assessments of UNDP results and performance. This change reflects the importance that the UNDP Executive Board and UNDP management place on transparency and accountability. Our collective work will be further strengthened by improving organizational effectiveness through the ongoing close collaboration and teamwork with all Bureaux and colleagues in the field. This shift is consistent with the efforts of our peers, including independent evaluation units within the Global Environment Facility (GEF), International Fund for Agricultural Development (IFAD), International Monetary Fund (IMF) and the World Bank.

I would also like to take this opportunity to announce the launch of IEO's new website [www.undp.org/evaluation](http://www.undp.org/evaluation). The site has been re-designed using tools and enhancements, to simplify and improve access to evaluation resources and enhance engagement. It features a new interactive design, improved searchability, easy navigation, new content structure and updated repository of our products.

I look forward to working together to strengthen the evaluation function.

The Gender Equality Evaluation Portal is an inter-active hub for gender evaluations, in which 300+ evaluations on gender equality policies, programmes and projects from different stakeholders and countries are available for free access.

The portal is framed around the 12 Areas of Concern outlined in the Beijing Platform for action, and further classified by evaluation type. It hosts evaluations completed between 2004 to present, published in English, Spanish, French and German. The Gender Equality Evaluation Portal has been designed to be dynamic, inter-active, open-content knowledge management system, where additional gender equality evaluations - and resources and tools – can be uploaded by users by registering at <https://genderevaluation.unwomen.org/accounts/login>
